What is Middle States Accreditation?

- Regional accrediting body (525 institutions)
- Middle States Commission on Higher Education (MSCHE) accreditation is an expression of confidence in an institution's mission and goals, its performance, and its resources.
- An institution is accredited when the educational community has verified that its goals are achieved through self-regulation and peer review.



Commission Decision

- a. Unconditional reaccreditation
- b. Warning
- c. Probation
- d. Show cause
- e. Withdrawal (eventually)
